

STUDENT PARKING RULES & REGULATIONS

Please READ the rules, FILL out the application, SIGN the agreement and BRING the application with the REQUIRED APPLICATION ITEMS as mentioned below to the school.

Please bring *PHOTOCOPIES* of documents – We cannot make copies.

APPLICATION ITEMS

You must present your current North student ID.

PHOTOCOPIES: The following items are required to register up to 3 family vehicles, which must be registered to an immediate family member listed in X2 Contacts. It is the student's responsibility to provide copies of these items:

1. Valid driver's license
2. Current vehicle registration(s)
3. Current proof(s) of liability insurance, to include company name, policy no., vehicle and expiration date.

REQUIREMENTS

- Grade average of C- or above in the prior quarter.
- No outstanding fees/books owed.

PAYMENT (not prorated during school year)

Cash (exact amount) or Check (payable to NHS NORTH):

- Per school year \$100.00
- Per Semester - \$50.00
- Change/Replace for any reason - \$5.00

Parking ID & Bus Pass – **Proof of bus payment required.**

Both bus & parking per school year - \$125.00

Both bus & parking per semester - \$62.50

NOTE: No refunds.

SUBJECT TO TOWING

- Any vehicle not parked in a designated Student Parking Area.
- Parking Pass not hung properly on your rearview mirror with license plate number in clear view.
- Improper use of Parking Pass.
- License plate not matching Pass plate numbers.
- Towing a vehicle may happen with NO advanced warning.
- Towing charges will be paid at the owner's expense.

ADDITIONAL INFO

- Only vehicles listed on the application/parking ID may be driven/parked on the NHSN campus.
- Parking IDs may not be transferred or resold.
- Loss of Parking ID must be reported to your academy immediately.

NOTICE: CAMPUS PARKING WITHOUT CURRENT NORTH PARKING PASS

If your vehicle is parked on campus without your current parking pass displayed properly on your rearview mirror, the vehicle will be subject to ticketing by the Nashua Police Dept. and/or towing by the Nashua School District at your expense.

REASONS PARKING PASS MAY BE REVOKED

- *Failure to follow school behavioral standards.*
- *Leaving school without permission, to include driving between North/South campuses, may result in loss of parking privileges.*
- *Inappropriate use of Parking Pass (i.e., on any vehicle not on parking application).*
- *Vehicle is not operated in a safe and legal manner.*
- *Failure to follow the Parking Rules & Regulations.*
- *Failure to maintain parking requirements.*
- *Excessive tardies/absences.*
- *Students will NOT be entitled to a refund if Parking Pass is revoked.*
