

STUDENT PARKING RULES & REGULATIONS

NHS SOUTH

Please READ the guidelines, FILL out the application, SIGN the agreement (parents, too) and BRING the application with the "REQUIRED APPLICATION ITEMS". Picking up this application does not give students permission to park on campus.

REQUIREMENTS

- No more than one non-passing grade (F or NC) during prior grading period.
- No outstanding fees/books owed.
- Only vehicles listed on the application/parking ID may be driven/parked on the NHSS campus.
- Parking in the gym lot must be on the baseball field side of the yellow line.

REQUIRED APPLICATION ITEMS

The following items are required, along with the application, to register your family vehicle(s). Expired documents will not be accepted:

- a. Current valid driver's license
- b. Current (**unexpired**) vehicle registration for **each car** listed. **NO TEMPORARY 20 day plates**. All vehicles must be permanently registered before an application is accepted.
IMPORTANT: Any vehicle, including new vehicles purchased during the school year, that has temporary license plates cannot be parked on campus. You may use Stellos Stadium parking spaces until the vehicle is permanently registered.
- c. Current proof of insurance(s) showing: name of company, policy #, vehicle year, make, model and policy expiration date (cannot be expired) for each car. **NO VEHICLES MAY BE PARKED ON CAMPUS WITHOUT PROOF OF INSURANCE ON FILE IN THE MAIN OFFICE.**
- d. Payment – cash or check payable to "NHS South" (along with paid receipt of bus pass purchase, if applicable)

NOTE: Up to 2 family vehicles are allowed on your Parking ID – vehicles must be registered to an immediate family member.

COST

Cash or check made payable to NHS SOUTH:

Car Only: * Full Year - \$100.00
* Semester - \$50.00

Car with Bus Pass receipt:

* Full Year - \$60.00 car with paid bus pass receipt
* Semester - \$30.00 car with paid bus pass receipt

NOTE: Purchasing a Sem 1 only pass does not guarantee a parking spot for Sem 2. You may be put on a wait list.

SUBJECT TO TICKETING & TOWING

- Vehicles not parked in a designated Student Parking Area.
- Parking ID not properly attached, with its own sealant, to the lower left corner of the driver's side rear window.
- Improper use of Parking ID.
- If license plate does not match ID.
- Towing and/or ticketing a vehicle may happen with NO advanced warning.
- Towing charges will be paid at the owner's expense.
- Cars may be searched, based upon reasonable suspicion.

REASONS PARKING PASS MAY BE REVOKED

- Failure to follow school behavioral standards.
- Leaving school without permission will result in loss of parking privileges as follows:
 - 1st offense: one (1) month
 - 2nd offense: remainder of the school year
- Parking ID used on any vehicle other than one on file at the high school.
- Vehicle is not operated in a safe and legal manner.
- Failure to follow the Parking Rules & Regulations.
- Failure to remain a student in good standing.
- Excessive tardies and/or suspensions.
- Students will NOT be entitled to a refund if Parking ID is revoked.
- Violation of any of the Requirements.

ADDITIONALLY

- Parking IDs may not be transferred or resold.
- Lost Parking ID must be reported to the Main Office immediately.
- There are no refunds. Students will NOT be entitled to a refund if Parking ID is revoked.
